# **Quotation Request / Work Orders**

An embedded form creation function is used to autogenerate the quote request or work instruction form which can be emailed directly to the supplier.

Approved contract budget changes are automatically updated across all modules for real-time information.

#### **Payment Scheduling**

Features such as payment scheduling and 'Payments Clock' enable count down stage payments, highly relevant for capital works projects or large construction payments.

#### **Financial Reporting**

The BUDGETS module enables greater visibility into accurate contract financial data in real-time. Financial summary can display cash-flow forecasts, actual vs committed spend, extra works costs, payment history, contract variations and adjustments.
